30. What is globalization as it pertains to counseling? Briefly explain the implications of globalization for the counseling profession.

\*a. Globalization refers to the idea that the world is becoming increasingly smaller because people of the world experience greater connectedness, particularly through social media, than ever before, and immigrants with different cultural backgrounds are arriving in the United States often need mental health services. Traumatic events in different parts of the world now resonate and impact the rest of the world more than ever before, and counselors are often called upon to help address mental health concerns. The implications of this connectedness for the counseling profession include a greater challenge to the counselors to provide mental health services, directly and indirectly; the need for the counseling profession to train and promote international counseling competency; and an imperative to address cultural specific issues related to individuals' international identity. Whether the work is in the United States or abroad, counselors' ability to serve people with international backgrounds will be expected and tested. Due to globalization, the counseling profession is faced with expanded role beyond the United to assist, interact, and learn from international colleagues that are trying to develop counseling professions in their countries and communities and to promote the role of social justice, advocacy and acceptance of cultural plurality. The prevailing expectation is that professional counseling in the 21st century has to meet the needs of culturally diverse individuals, groups, and communities. 31. Briefly explain the concept of oppression by isms and its implications; include examples to clarify your answer.

\*a. Oppression by isms refers to social injustice experienced by individuals because of their membership in a group that is defined by an ideology of ism, such as sexism, racism, ageism, heterosexism, and other isms. In the United States, individuals belonging to such groups have different realities than members of the majority group. For example, majority group members often enjoy unearned advantages while those with minority group membership find themselves in disadvantageous positions. Based on the conclusion of the President Clinton's Advisory Board to the President's Initiative on Race as indicated in the text, racism is the most divisive force in the United States. The text further indicate that the presence of racism and other isms is the reason American democratic society has an unjust side that denies members of minority groups access to resources, wealth, and opportunities. An example is that White people benefit from White-skin privileges that provide access to resources and exempt them from oppression that members of minority group do not. However, White people may experience oppression because of reasons other than being white, such as sexism, classism, and ageism. Such oppression operates at different levels, including individual and societal levels exposing marginalized people to discrimination and victimization.

32. How would you answer this question: Is multicultural competence really needed? \*a. Who a counselor is and her or his cultural awareness and competence will influence how she or he works with culturally diverse clients; because of the presence of social oppression and privilege, work with clients cannot be one size fits all or consist of "treating everyone the same"; different groups, including counselors, see different realities. Unless counselors develop their cultural selves and multicultural competence, they will not be able to help and could likely harm culturally diverse clients. The negative role of oppression and social injustice on culturally diverse clients' mental health must be acknowledge and considered in the counseling process. The traditional medical model approach to counseling has been found to fail the marginalized groups and contribute to underutilization of counseling services by this group. As a result, the counseling profession runs the risk of being multiculturally insensitive and ineffective. Lastly, counselors' professional and personal biases may result in unintentional harm to clients.
