## OFF 2: Introduction to the Windows 10 Operating System

### LECTURE NOTES

- Introduce Windows 10 and define operating system, app, gesture, scroll bar, scroll arrows, scroll box, keyboard shortcut, user account, user name, password, user icon, lock screen, sign-in screen, Recycle Bin, and file
- Use Figure 1 to illustrate using the desktop
- Use Tables 1 and 2 to illustrate using a touch screen and a mouse
- Use Figure 2 to illustrate scrolling
- Use Figures 3 to illustrate the lock screen
- Use Figures 4 and 5 to illustrate signing in to an account

### TEACHER TIPS

If you are at a location that requires user id's and passwords for your workstations, check with someone on your tech support staff to make sure that all of your students have a login and password. If you plan, it will save frustration when the students go to the lab for the first time.

Double-clicking can be a difficult skill to master. Students may not click quickly enough, or may move the mouse between the first and second click. With practice, however, double-clicking soon should become second nature.

Learning how to drag takes practice as well.

### CLASSROOM ACTIVITIES

1. Class Discussion: Ask students what operating system they are running on their PCs at home and/or at work. What do they like about their operating system? Why was that operating system chosen for their home or place of work?

2. Class Discussion: Ask the class to share the types of activities that they do with their personal computers. How many have a computer network in their home? Ask them to brainstorm the advantages of a computer network over non-networked computers.

3. **Class Discussion:** Many injuries have been related to continued keyboard use. Repetitive stress injury (RSI), a type of musculoskeletal disorder, afflicts more than 1.8 million people in the United States. The Bureau of Labor Statistics reports that work-related musculoskeletal disorders account for one-third of all occupational injuries and illnesses. These disorders are the largest job-related injury and illness problem in the United States today. Whose responsibility is safe computer usage — the employee or the employer?
4. **Group Activity:** Divide the class into small groups. Have each group play “Hot Ball” using questions based on Table 1 on page OFF 3 of the text. That is, one person asks, “What is the gesture for ‘tap’?” and tosses the “Hot Ball” (can be a ball, a crumpled up page of paper, or whatever) to another student, who answers, “Quickly touch and release one finger one time” (or words to that effect). Then, the answerer asks and tosses, and so on. Make sure each group covers all of the items in the table. Do the same for Table 2 on page OFF 4, having students ask questions about mouse operations.
5. **Assign a Project:** Have students examine the desktop on the computers of several different people. Note the differences and similarities. Then, have them write a brief report detailing their findings, including in detail whose computers they looked at and why they think that person chose those desktop icons, backgrounds, and so on.
6. **Assign a Project:** Developing icons for a graphical user interface, like that used by Windows 10, is not an easy task. A good icon need not be a work of art, but it must be a memorable symbol of the task it represents. According to Susan Kare, creator of the icons used with many popular GUIs, “The best icons are more like traffic signs than graphic illustrations.” Have students choose three commonplace activities (walking to class, calling for a date, and so on) and, using three sheets of graph paper, create an icon to represent each. Color the appropriate squares on the graph paper to create the image for each icon. On the back of the graph paper, have students explain why the icon is suitable for the activity chosen.
7. **Assign a Project:** Once a nondescript box perched on a large ball bearing, today the computer mouse comes in a wide range of shapes with a variety of capabilities. There are cordless mice, ergonomic mice, whimsically designed mice, ring mice (worn on the finger like a ring), and even tough mice that can be dropped from a five-story building, plunged under water, or run over by a truck without damage. Information about different types of mice can be found on the World Wide Web. Have students visit several websites to find out more about the mouse. Which mouse is the most unusual? Why? Which mouse has the most capabilities? Which mouse is least expensive? Which is most expensive? How is the difference in price justified? Which mouse would they most like to own? Why?
8. **Quick Quiz:**
  - 1) What is an operating system? (Answer: A computer program that coordinates all the activities of computer hardware, such as memory, storage devices, and printers)
  - 2) Which 'Shut down options' command waits for Windows 10 to save your work and then turns off the computer fans and hard disk? (Answer: The Sleep command)
  - 3) What is a password? (Answer: A private combination of letters, numbers, and special characters associated with the user name that allows access to a user's account resources)

- 4) What is a scroll bar? (Answer: A horizontal or vertical bar that appears when the contents of an area may not be visible completely on the screen)

#### LAB ACTIVITIES

1. Different factors add to a computer's start up time. Have students turn on their computers and, using a stopwatch or the second hand on a watch or clock, determine how long it is from the time the computer is turned on until the Windows 8 Welcome screen appears. Encourage them to discuss the launch time of their computers with other students. How does it compare? Have students make a list of the factors they think were in play for their machine and how they compare to other students.
2. Tell students that there are a number of accessories in Windows 10. Ask the students to look at the Accessories folder on their workstations and make a list of the accessories and what they are used for. Some of the accessories they may not have access to use. You also could divide the class into groups and assign each group a different topic.

## WD 57: Project — Research Paper

### LECTURE NOTES

- Identify the two popular documentation styles for research papers, the Modern Language Association of America (MLA) and the American Psychological Association (APA)
- Use Figure 2-1 to illustrate the research paper created in this project, and to point out the spacing, margins, indentation, and page numbers used in MLA style
- Use the Roadmap to review the general activities that will be performed in this module
  - Change the document settings
  - Create the header for each page of the research paper
  - Type the research paper text with citations
  - Create an alphabetical works cited page
  - Proofread and revise the research paper
- Discuss the specifics of the MLA documentation style
- Define parenthetical references
- Explain how explanatory notes are indicated and formatted
- Describe the works cited page

### TEACHER TIP

The Modern Language Association of America ([www.mla.org](http://www.mla.org)) was founded in 1883 and today has more than 30,000 members in 100 countries. The goal of the MLA is to strengthen the study and teaching of language and literature. The MLA provides opportunities for members to share scholarly findings and teaching experiences and discuss trends. The MLA hosts an annual convention and other meetings, works with related organizations, and publishes a quarterly newsletter and four major periodicals.

### CLASSROOM ACTIVITIES

1. Class Discussion: Ask students about their experience writing research papers. Survey them about their experience using either MLA or APA style. If possible, show a research paper written according to APA style as a companion piece to the paper in MLA style in Figure 2-1. Tabulate and present the results of this in-class survey.
2. Group Activity: Have students list some of the research documents they have had to create during the past several years and anticipate creating in the future. Ask them to put an “I” beside the names of

those that contain information obtained from the Internet and a “C” beside the names of those for which they used a computer to create the final document.

3. Quick Quiz:

- 1) What term does the MLA documentation style use for bibliographical references? (Answer: Works cited)

4. Critical Thinking: Most schools and businesses require some standard style of documentation for written reports. Why? What disadvantages, if any, might there be to insisting that all reports conform to a certain style?

#### LAB ACTIVITIES

1. Ask students to use computers in the lab to visit the MLA and APA Web sites for details about these styles, and to write a report that compares and contrasts the MLA and APA documentation styles according to their findings in the lab.

### WD 60: Changing Document Settings

#### TEACHER TIPS

For more precision in setting a first-line indent, you can click the Paragraph Dialog Box Launcher, click the Indents and Spacing tab, click the Special box arrow, and then click First line.

Students should be careful what they add to the AutoCorrect list. For example, suppose they frequently type “from” as “form” and they decide to put this on their AutoCorrect word list. If they do, they will have problems if they really mean to type “form.”

Point out that you can have Word modify a style automatically, meaning that Word detects when you alter the formatting of text containing a style, and then automatically updates the style. When Word automatically updates the style, all text formatted with that style is updated to match the formatting of the text you just changed.

Automatic page breaks are called “soft” because they can change as text is added to, or deleted from, a document. Manual page breaks, which are discussed later in this project, are called “hard” because they do not change.

#### CLASSROOM ACTIVITIES

1. Group Activity: Divide the class into small groups. Ask each group to play “Hot Ball” using Tables 2-1 and 2-2 on page WD 71 of the text. That is, one person asks, “What is the shortcut key for ‘changing the case of letters?’”, and tosses the “Hot Ball” (can be a ball, a crumpled-up piece of paper, or

whatever) to another student, who answers. Then, the answerer asks and tosses, and so on. Have each group cover all of the items in the two tables.

2. **Class Discussion:** All of the formatting tasks described in Tables 2-1 and 2-2 can be performed using commands accessed in other ways. Shortcut keys can save time but, of course, they must be memorized to be used. Considering the types of documents you feel you will most likely create in the future, which shortcut keys in Tables 2-1 and 2-2 would be most important to memorize? Why?
3. **Class Discussion:** Poll the class on whether, as readers, they prefer footnotes or endnotes and why. Unless there are several explanatory notes on a page or the notes are very long, most readers probably favor footnotes.
4. **Assign a Project:** Ask students to view the contents of the AutoCorrect tab in the AutoCorrect dialog box and note the list of things that Word corrects automatically. If any of these things do not fit with the way they type, they can uncheck them by selecting them. Next, ask them to look at the list of words that Word will AutoCorrect and make note of any words that they commonly misspell.
5. **Assign a Project:** Have students open several different documents in Word and do a word count in each one. Ask them to keep track of the word and line count for each document, and then calculate the average number of words per line in the documents.
6. **Quick Quiz:**
  - 1) What is a tag name? (Answer: An identifier that links a citation to a source)
  - 2) Do you have to type the footnote text for one footnote before you can add another? (Answer: No)
  - 3) Will Word keep track of the numbering of footnotes if you rearrange, insert, or remove them? (Answer: Yes)
7. **Critical Thinking:** Check boxes in the AutoCorrect dialog box (Figure 2-27) instruct Word to correct two initial caps, capitalize the first letter of sentences, capitalize the first letter in a table cell, capitalize names of days, correct accidental use of caps lock, and replace text as it is typed. When might you want to set an exception to any of Word's AutoCorrect features? Why?
8. **Critical Thinking:** Word count often is important when writing research papers. In what other situations might word count be important (i.e., when might it be necessary to have a minimum, or maximum, number of words in a document)?

### TEACHER TIPS

There are a number of different ways to adjust page breaks in a document. A manual page break can be deleted. Although automatic page breaks cannot be deleted, a number of paragraph options can be used to adjust automatic page breaks. If automatic page breaks occur at an undesirable location, students can select the paragraph before or after the unwanted page break, use (or remove) the Keep lines together, Keep with next, and Page break before features. Certain section breaks (Next page, Even page, or Odd page section breaks) also will break a page.

Explain that the content of references on a works cited page is the same for most styles of documentation, but the order in which they are presented may vary. For written works, references usually include the author's name, the title of the work, the place of publication, the publisher's name, the date of publication, and the page number on which the reference is found. For electronic sources, some items may be changed or missing. For example, in place of a title there may be a file name; the place of publication and the name of the publisher may be replaced by the protocol and address. On the Web, page numbers often have little or no meaning. Because most Web browsers allow users to search for specific words or phrases within an electronic document, designating the location of a specific reference usually is unnecessary. Whether a source is written or electronic, however, mention to students that experts agree that when in doubt about what information to include, it is better to have too much than too little.

#### TEACHER TIPS

Emphasize as strongly as possible that Word's spell check and grammar check will catch many errors, but it will not catch all errors (such as homonyms).

Caution students to be careful when using find and replace to give enough of the word or phrase they want to replace so as to be sure that Word will do only what they want it to. For example, suppose for some reason students decide to replace every occurrence of the word "he" with the word "Bob". If they are not careful, they may end up with the word "the" becoming the word "tBob." To avoid this, they can type " he" (i.e., [space] he) in the Find what text box, and " Bob" ([space] Bob) in the Replace with text box.

Students may be surprised to learn that Word's standard dictionary does not contain every correctly spelled word. The dictionary contains most common words, but it might not include technical terms, proper names, acronyms, and so on. If students frequently use special terminology, or if they often use a name that does not appear in Word's standard dictionary, they may want to add the terminology or name to Word's custom dictionary so that these words are not flagged as spelling errors. Mention as well that it is possible to have multiple custom dictionaries.

1. Class Discussion: The Synonyms submenu offers a list of synonyms for a word. Is it always a good idea to use whatever synonyms are presented on the Synonyms submenu for a given word? Why or why not?

Some college students have no qualms about lightening their workload by copying and pasting information from a website into their research papers. What is plagiarism? (A good definition is “using someone else’s words or ideas and claiming them as your own.”) What are the ethics of plagiarism?

### Wearable Devices

A wearable device or wearable is a small, mobile computing device designed to be worn by a consumer. These devices often communicate with a mobile device or computer using Bluetooth. Three popular types of wearable devices are activity trackers, smartwatches, and smart glasses.

An activity tracker is a wearable device that monitors fitness-related activities such as distance walked, heart rate, pulse, calories consumed, and sleep patterns. These devices typically sync, usually wirelessly, with a web or mobile app on your computer or mobile device to extend the capability of the wearable device (Pappas 32-41).

A smartwatch is a wearable device that, in addition to keeping time, can communicate wirelessly with a smartphone to make and answer phone calls, read and send messages, access the web, play music, work with apps such as fitness trackers and GPS, and more. Most include a touch screen (Carter and Schmidt).

Smart glasses, also called smart eyewear, are wearable head-mounted eyeglass-type devices that enable the user to view information or take photos and videos that are projected to a miniature screen in the user's field of vision. For example, the device wearer could run an app while wearing smart glasses that display flight status information when he or she walks into an airport. Users control the device through voice commands or by touching controls on its frame. Some smart glasses also include mobile apps, such as fitness trackers and GPS (Yazzie).

Activity trackers, smartwatches, and smart eyewear are available from a variety of manufacturers. Before making a purchase, consumers should research costs and features of all options to determine the device that best suits their requirements.

### Two-Step Verification

In an attempt to protect personal data and information from online thieves, many organizations, such as financial institutions or universities, that store sensitive or confidential items use a two-step verification process. With two-step verification, a computer or mobile device uses two separate methods, one after the next, to verify the identity of a user.

ATMs (automated teller machines) usually require a two-step verification. Users first insert their ATM card into the ATM (Step 1) and then enter a PIN, or personal identification number, (Step 2) to access their bank account. If someone steals these cards, the thief must enter the user's PIN to access the account (Tanaka).

Another use of two-step verification requires a mobile phone and a computer or mobile device.<sup>1</sup> When users sign in to an account on a computer or mobile device, they enter a user name and password (Step 1). Next, they are prompted to enter another authentication code (Step 2), which is sent as a text or voice message or via an app on a smartphone. This second code generally is valid for a set time, sometimes only for a few minutes or hours. If users do not sign

in during this time limit, they must repeat the process and request another verification code (Marcy). Microsoft and Google commonly use two-step verification when users sign in to these websites (Moore and O'Sullivan).

Some organizations use two separate methods to verify the identity of users. These twostep verification procedures are designed to protect users' sensitive and confidential items from online thieves.

### Types of Databases

Every database is based on a specific data model.<sup>A</sup> A data model defines how users view the organization of the data. It does not define how the operating system actually arranges the data on the storage media. Three popular data models in use today are relational, object-oriented, and multidimensional.

A relational database is a database that stores data in tables that consist of rows and columns. In addition to storing data, a relational database also stores data relationships. A relationship is a link within the data. Applications best suited for relational databases are those whose data can be arranged into a two-dimensional table. That is, they can exist as tables with rows and columns. Many organizations use relational databases for business areas. Examples include payroll, accounts receivable, accounts payable, general ledger, inventory, order entry, and invoicing.

An object-oriented database (OODB) stores data in objects. An object is an item that contains data, as well as the actions that read or process the data. One example use of an OODB is a media database that store images, audio clips, and/or video clips. Another example is a groupware database that store documents, such as schedules, calendars, manuals, memos, and reports. A third example is a CAD (computer-aided design) database that stores data about engineering, architectural, and scientific designs (Mendez).



A multidimensional database stores data in dimensions. Whereas a relational database is a two-dimensional table, a multidimensional database can store more than two dimensions of data. These multiple dimensions allow users to access and analyze any view of the database data. One use of multidimensional databases is a data warehouse.<sup>B</sup> The database in a data warehouse often is distributed. The data in a distributed database exists in many separate places in a network or the Internet. The data is accessible through a single server. The actual location of the server on which it is stored is transparent, and often unknown, to the user (Wang and Patel).

Organizations often use a database to manage business or other functions. A database usually is based on one data model. Current data models include relational, object-oriented, and multidimensional.

### Safely Using Headphones and Earbuds

People often listen to sound from their computers or mobile devices through headphones or earbuds. Headphones cover or are placed outside of the ear, whereas earbuds rest inside the ear canal. With these listening devices, only the individual wearing the device hears the sound. Using headphones or earbuds improperly can lead to permanent hearing loss. Items that may protect hearing include quality of these devices and volume levels.

The features of certain headphones and earbuds can help to prevent hearing loss. Higherquality headphones and earbuds tend to produce a clearer sound, enabling wearers to listen at a lower volume (Tu). Properly designed headphones should have a close fit for optimal listening.

Similarly, earbuds should seal tightly in the ear canal of the person wearing the device.

Headphones and earbuds also should include noise-cancelling technology.<sup>1</sup>

The volume level of the sound that transmits from headphones or earbuds into the ear of a person wearing this type of device has been linked to hearing loss. The volume should be set low

enough that other people nearby cannot hear the sound being transmitted. The quieter the sounds, the less possibility of hearing damage. Further, listening at a higher volume for extended periods of time could be unsafe. One expert suggests people should listen at only 30 percent maximum volume (Chamberlain).

More and more people are using headphones and earbuds with their computers and mobile devices. Using high-quality listening devices and lowering the volume can help to minimize potential hearing loss from the use of headphones and earbuds.
